**CALL FOR APPLICATIONS FOR CIVIL SOCIETY ORGANISATIONS AS LEAD SUB-
RECIPIENTS TO THE CHAZ GF HIV/TB ACCELERATING TOWARDS EPIDEMIC
CONTROL II (ATEC)**

FOCUS GROUP: Lead CSOs (2)

FUNDING: Subject to Grant Signing and Approved Budgets

Background

The Churches Health Association of Zambia (CHAZ) is an umbrella organization of 157 Faith Based Organizations that include Mission Hospitals, Mission Rural Health Centers and Community Based Organizations. Having bilateral and multilateral partnerships with local and international organizations, CHAZ is one of the Principal Recipients (PRs) of the Global Fund grants in Zambia under Global Fund ATEC II which will run for a period of 3 years from 1st January 2021 to 31st December 2023. This funding necessitates the need to engage Two (2) Civil Society Organisations as Lead Sub-Recipients to implement various activities under the Prevention and Resilient and Sustainable Systems for Health (RSSH) modules of the grant. Therefore, this call seeks to select Civil Society Organisations as Lead Sub -Recipients to implement through Sub Sub Recipients (SSRs) activities under the thematic area below. Applications are therefore sought

from institutions that meet the requirements and have the capacity to implement activities under the thematic area.

Module: Prevention Programs with the Following Interventions:

Intervention I - Gender-Based Violence Prevention and Post Violence Care

Target Population: Adolescent Girls and Young Women Including People Living With Disabilities

Activities:

1. To build capacity of community volunteers and providers (i.e. community volunteers, Para-legal volunteers, community leaders, youth leaders) in Sexual and Gender Based Violence (SGBV)
2. To build capacity of health workers through training and mentorship in the provision of a package of essential post-violence healthcare interventions
3. Support victims of Sexual and Gender Based Violence (SGBV) with transport fees to access certain facilities

Intervention II -Sexual and reproductive health services, including STIs

Target Population: Adolescent Girls and Young Women Including People Living With Disabilities

Activities:

1. To build capacity of Peer Educators through trainings and mentorships, for the provision of Sexual and Reproductive Health Education in tertiary institutions.
2. To capacity build health workers in value clarification and delivery of package of adolescent friendly health services in 40 districts
3. Train Youth peer educators in the delivery of Sexual Reproductive Health and Rights (SRHR) services/Adaptive Leadership , both for in and out of schools including tertiary institutions to enhance peer to peer counselling and linkage to accessing services in health facilities
4. To Conduct bi-monthly integrated outreach health services focusing on delivery of minimum package for adolescent health in 40 districts targeting schools (primary, secondary and tertiary), community and other institutions (prisons and refugee camps)
5. Formation or strengthening of school clubs (including formation of girls and boys clubs as platforms to address issues specific to girls and boys)

Module: Resilient and Sustainable Systems for Health with the following Interventions:

Intervention I - Social mobilization, building community linkages and coordination

Target Population: Adolescent Girls and Young Women Including People Living With Disabilities

Activities:

1. Scale up number of Civil Society Organizations (CSOs) implementing SBC activities
2. Conduct community engagement activities

Objectives of the Call for Applications

To invite eligible Civil Society Organisations (CSOs) to submit applications to become Lead Sub-Recipients (LSRs) under the **GF HIV/TB Accelerating Towards Epidemic Control II (ATEC)**.

Lead CSOs Sub-Recipients

These organisations will be expected to receive grants for implementing activities among sub sub recipients (SSRs). They will provide capacity building, technical support, mentoring, grant management and administration, financial and risk management and monitoring and evaluation. The Lead Sub Recipient must show strong history of implement evidence based HIV/TB programming and Grant Management, and demonstrated good capacity for grant appraisal, capacity building and programme management, monitoring and evaluation.

Application Procedure

CSOs meeting the above requirements should submit their **applications using the CHAZ proposal format** and a cover letter, on their organizations' letterhead, highlighting the following:

- Name of the CSO, contact information including physical and postal address
- Year of establishment and copy of a certified registration certificate
- Annual Returns to registrar of societies
- Certified copy of the Constitution (copy stamped by the Registrar of Society)
- Show an established provincial presence to ensure geographical spread, with evidence of key stakeholder support
- letters of Support from current/previous partners working or worked with the organisation

- Institutional capacity statement
- Governance structure showing clearly the governance and management structure

Submission Mode

All applicants must submit their sealed expression of interest documents to the CHAZ Complex reception desk. The applications/expressions should be clearly marked “**APPLICATION AS LEAD SUB RECIPIENT UNDER THE CHAZ –GF HIVTB ATEC LCSO**” and **addressed to the Executive Director, Churches Health Association of Zambia, CHAZ Complex, Plot 2882/B/5/10 Mission Drive, P O Box 34511, Lusaka Zambia. The Applicant must clearly state which Module(s) and intervention(s) they are applying for.** All applications should arrive at or before 14:00 hour’s local time on Monday 4th January, 2021 and dropped in a tender box marked as SR application placed at the CHAZ Complex Gate. Application will be opened in the CHAZ Board room to be registered for review. Assessment of application will be based on merit, coverage, experience and past performance for repeat applicants. Any applications not meeting any of the above requirements will be rejected. Similarly late applications or emailed applications will not be considered.

CHAZ reserves the right to accept and/or reject an application. Clarifications can be emailed to grants@chaz.org.zm only until 22nd December 2020 responses to clarifications will be uploaded on the website by 23rd December 2020.

Upon selection, the successful SRs will be published in the local media. Please note that the funding under this Grant is limited and only a maximum of 2CSOs to be selected under this category based on the quality of their proposals and evidence provided during site assessments.
